





Either party may terminate the Memorandum of Understanding at any time by written notice signed by an appropriate official of the party initiating the notice. The other party must receive the notice at least six months before the effective date of termination of ongoing activities and programs undertaken under this Memorandum of Understanding, prior to the date of termination of this Memorandum of Understanding unless otherwise jointly decided upon by the Parties.

Article V: Settlement of Disputes

Any dispute or differences arising out of the interpretation or implementation of this Memorandum of Understanding shall be settled amicably through consultation or negotiations between the Parties.

Article VI: Final Provisions

This Memorandum of Understanding shall be adequate when the Parties' representative has affixed their signatures.

The termination of this Memorandum of Understanding will not affect the implementation of on-going activities and/or programs undertaken pursuant to this Memorandum of Understanding, prior to the date of termination of this Memorandum of Understanding unless otherwise jointly decided upon by the Parties.

Article 5: Settlement of disputes

Any dispute or differences arising out of the interpretation or implementation of this Memorandum of Understanding shall be settled amicably through consultation or negotiations between the Parties

Article 6 Final Provisions

MEMORANDUM OF UNDERSTANDING BETWEEN UNIVERSITY OF SOUTH-EAST ASIA, CAMBODIA AND SISAKET RAJABHAT UNIVERSITY, THAILAND



KNOW ALL MEN BY THESE PRESENTS:

This Agreement entered into by and between:

The UNIVERSITY OF SOUTH-EAST ASIA, was created and operating through Sub-decree No. 63 dated 07 July 2006; duly signed by his Excellency Prime Minister Hun Sen under Prakas No. 802 dated 09 July 2007 of the Ministry of Education Youth and Sports (McEYS) with office address at 7 January Road, Wat Bo Village, Sangkat Salakamreuk, Siem Reap Municipality, Siem Reap Province, Kingdom of Cambodia duly represented herein by its Acting President, DR. MEAN SOTHY, hereinafter referred to as "USEA".

and

The SISAKET RAJABHAT UNIVERSITY is one of the higher education institutes recognized by the government and situated in the province of Sisaket province, the part of northeastern Thailand. The university was first established as 'Sisaket Rajabhat Institute' in 2001. It was changed into the university in 2004 with principal office address at 319 Pho district, Museung Sisaket District, Sisaket 33000, Kingdom of Thailand represented by its Rajabhat University Act, B.E. 2547, hereinafter referred to as 'SSKRU'

WITNESSETH THAT:

WHEREAS, USEA and SSKRU agree to cooperate on exchange programs based on equality and reciprocity;

WHEREAS, the exchange of faculty, students, researchers, scholars, administrative staff and academic information and materials shall enhance research and educational process for both parties.

WHEREAS, the exchange program shall promote academic and educational cooperation and promote mutual understanding between the respective faculty, students and scholars of the parties;

NOW, THEREFORE, in consideration of the above, the Parties hereby agree as follows:

- The universities agree to develop the following collaborative activities in academic areas of mutual interest:
 - a. Exchange of faculty, students, researchers and other and administrative staff,
 - Exchange of academic information and research publication;
 Conduct of joint research projects and joint degree programs;
 - d. Conduct of joint lectures, conferences, training and symposis;
 - Exchange of academic information materials, library cooperation and credit transfer,
 - f. Promotion of other academic cooperation as agreed by both universities; and
 - g. Establishment of Khmer Thai Studies Center in both universities.
- The development and implementation of specific activities based on this Agreement will be separately negotiated and agreed upon between the faculties, schools or institutes which carry out these activities in accordance with the laws and regulations of the respective countries after full consultation and approval.
- It is understood that the implementation of any of the types of cooperation stated in clause 1 may be restricted depending upon the availability of resources and financial support at the universities concerned.
- All collaborative activities and exchanges under this general MOU shall not be conducted or enforced unless a specific Activity Agreement is executed between the parties herein observing the same formalities and all limitations specified herein.

- Nothing shall diminish the full autonomy of either institution, nor will any constraints be imposed by either upon the other in carrying out the agreement.
- Should any collaborative research activity under this Agreement result in any potential for intellectual property, both universities shall seek an equitable and fair understanding as to the ownership and other property interests that may arise. This understanding shall be based on the laws, rules and guidelines then implemented in each university.
- 7. Subject to the governing law of each institution's jurisdiction regarding public records, the universities agree not to use or disclose to anyone information belonging to the other party which is disclosed in connection with this Agreement which is of confidential nature and agree not to make any announcements of any nature in respect to this Agreement without the consent of the other party hereto.
- This agreement may be amended or modified by a written agreement signed by the representatives of both universities.
- In the event of any unforeseen incident during collaborative activities in either country, both universities agree to negotiate a mutually acceptable solution.
- As far as practicable these solutions shall be incorporated in the specific agreements mentioned in clause 4.
- 11. This agreement is valid for a period of five (5) years from the date of signing by the representatives of both universities. This agreement shall be renewed after being reviewed and renegotiated by both universities.
- 12. This Agreement may, at any time during its period of validity, be terminated by one of the universities, upon prior notice to the other in writing not later than six (6) months before the termination date.
- 13. Should any disagreement arise out of the application, interpretation or implementation of this Agreement, the universities shall endeavor to exercise best efforts to negotiate their differences. Alternative methods of dispute resolution shall be exhausted before resort to court litigation.



MEMORANDUM OF UNDERSTANDING BETWEEN

I. PARTIES

This Memorandum of Understanding (hereinafter referred to as "MOU") is made by and between GUIZHOU UNIVERSITY OF FINANCE AND ECONOMIC (hereinafter referred to as "GUFE"), a public university where its official address at HUAXI University Town, Gulyang, 550025 Guizhou, China, of the first part and SISAKET RAJABHAT UNIVERSITY (horeinafter referred to as "SSKRU"), a public university where its official address at Pho Subdistrict, Musang district, Sisaket, 33000, Thailand, of the second part.

2. PURPOSE

The purpose of this MOU is to foster academic partnership and cooperation between GUFE and SSKRU.

3. POTENTIAL AREAS OF COOPERATION

Areas of future cooperation between GUFE and SSKRU may include, but are not limited to:

- i. Student exchange;
- ii. Suff exchange;
- iii. Exchange of information and publications:
- iv. Joint research activities and teaching programs;
- v. Joint student supervision:
- vi. Joint seminars/conferences; and
- vii. Other related fields as matual agreed in future.

Both institutions may emer into separate agreement, as necessary, to facilitate the said collaborative activities.

4. FINANCIAL OBLIGATIONS

It is recognized that this MOU involves neither obligations nor transfer of financial resources. Under this MOU, collaborative activities will be undertaken within the limits of available resources of the respective institutions. In terms of student and staff exchange, both parties provide free tuition and on-campus accommodation fees.

5. VALIDITY AND TERMINATION

This MOU comes into effect on the date of signing and will remain in effect for five (5) years from the date of signatures. The Chinese and English Version shall have the same legal effect. Two copies of this MOU are signed and each institution shall have one. It can be renewed by mutual consent of the institutions. Either institution may terminate this MOU without liability, for any reason and at any time, by giving a thirty (30) day advance written notice to the other institution. Where such termination occurs, the provision of the collaborative programs shall continue to apply to on-going activities until their completion.

This MOU is intended to promote and facilitate collaborative activities for mutual benefits and shall not be construed as creating any legal obligations between the institutions. Detailed cooperative matters involved in this MOU shall be made clear in an extra agreement signed by both institutions. This MOU is signed in Guiyang, China and Sisaket, Thailand.

- (c) Articulation Agreement by program
- (2) It is agreed that the terms and conditions of any agreed program and activity contemplated in this MoA shall be the subject matter of separate written agreements to be negotiated and agreed upon by both Parties and/or any third parties, wherever applicable. PROVIDED, the decision whether to initiate and/or implement any program or activity shall be at the sole discretion of each Party.
- (3) The Parties agree to designate, on behalf of each institution, a coordinator whose responsibility will be to supervise the execution of this MoA and to draw up programs or activities to be implemented under this MoA, setting out specific provisions concerning the exchange programs, budget requirements and details of funding. For this purpose, the coordinator for is the SSKRU, Office of International Affairs, and for CMU it is the President's Office.

- (2) The Parties acknowledge that all visits or exchanges of staff, students, or administrators will be subject to compliance with Thailand and the United States entry and visa regulations and with the respective party's requirements concerning staff and student visits.
- (3) This MoA is not intended to be legally binding. It merely expresses the intentions and understanding of the Parties, which will form the basis of any legally binding agreement to be drafted and executed in the future.
- (4) The Parties hereby agree that they are not bound exclusively by this MoA and shell be at liberty to enter into separate agreements or arrangements with any third party without reference to the other Party.

8. EXECUTION

This Memorandum of Agreement may be executed in one or more counterparts, each of which shall be doesned an original but all of which shall constitute the same instrument. The Parties shall be entitled to rely upon delivery of an executed electronic copy of this Memorandum of Agreement.

- (c) Further, this Memorandum of Understanding is effective for a term not exceeding five years, which term may be extended, provided the Memorandum of Understanding is under active negotiation and the collaborative research, training and academic partnerships is continuing.
- (d) It is understood that any party may revoke this Memorandum of Understanding at any time by giving written notice to the other parties.
- (e) This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create any legally binding or enforceable obligations, expressed or implied.

This Memorandum of Understanding shall come to effect when duly signed by both parties.
